("we" or "the Company") previously filed a Registration Statement on Form S-8 (File No. 333-156985) (the "Original Registration Statement") with respect to the Marshall Edwards, Inc. 2008 Stock Omnibus Equity Compensation Plan (the "Plan"). On December 1, 2011, our stockholders approved an amendment and restatement of the Plan to increase the aggregate number of shares of our common stock, par value \$0.00000002 per share (the "Common Stock") that may be subject to awards under the Plan by 1,800,000 shares. On February 21, 2012, we filed an additional Registration Statement on Form S-8 (File No. 333-179591) (the "Second Registration Statement") to cover such additional 1,800,000 shares of Common Stock. On December 3, 2014, our stockholders approved another amendment and restatement of the Plan to increase the aggregate number of shares of Common Stock that may be subject to awards under the Plan by an additional 1,750,000 shares. On January 26, 2015, we filed an additional Registration Statement on Form S-8 (File No. 333-201703) (the "Third Registration Statement" and, together with the Original Registration Statement, the "Prior Registration Statements") to cover such additional 1,750,000 shares of Common Stock. (2) That, for the purpose of determining any liability under the Securities Act, each such post-effective amendment shall be deemed to be a new registration statement relating to the securities offered therein, and the offering of such securities at that time shall be deemed to be the initial bona fide offering thereof.

(3) To remove from registration by means of a post-effective amendment any of the securities being registered which remain unsold at the termination of the offering.
